Introduction

It is intended for use as a tool for future planning and to promote partnership between resource providers and state, local, territorial, and tribal entities. R1. Community Facilities Direct Loan & Grant Program (10.766)

Resource Type: Grant and Loan

Agency/Organization: Department of Agriculture

Funding Type: Non-Supplemental

Program Description: This program provides affordable funding to develop essential community facilities in rural areas. An essential community facility is defined as a facility that provides an essential service to the local community for the orderly development of the community in a primarily rural area, and does not include private, commercial or business undertakings.

Eligible borrowers include:

- Public bodies
- Community-based non-profit corporations
- Federally-recognized Tribes

To construct, enlarge, extend, or otherwise improve community facilities providing essential services to rural residents. Community facilities include (but are not limited to) those providing or supporting overall community development - such as hospitals, fire protection, public safety, libraries, education facilities, child care facilities, food recovery and distribution centers, assisted living facilities, group homes, mental health clinics, and shelters. Projects comprise community,

social, health care, education, cultural, transportation, industrial park sites, fire and rescue services, access ways, and utility extensions. Funds may also be used to acquire land needed for a facility, to pay necessary professional fees, or to purchase equipment required for a facility's operation. All facilities financed in whole or in part with RHS funds shall be for public use.

R2. Community Facilities Technical Assistance & Training Grant (10.761)

Resource Type: Grant

Agency/Organization: Department of Agriculture

Funding Type: Non-Supplemental

Program Description: The Agency will make grants to public bodies and private nonprofit corporations, (such as States, counties, cities, townships, and incorporated towns and villages, boroughs, authorities, districts, and Indian tribes on Federal and State reservations) to provide associations Technical Assistance and/or training with respect to essential community facilities programs. The Technical Assistance and/or training will assist communities, Indian Tribes, and Nonprofit Corporations to identify and plan for community facility needs that exist in their area. Once those needs have been identified, the Grantee can assist in identifying public and private resources to finance those identified community facility needs.

Grant funds may be used to:

- Assist communities in identifying and planning for community facility needs;
- Identify resources to finance community facility needs from public and private sources;
- Prepare reports and surveys necessary to request financial assistance to develop community facilities;
- Prepare applications for Agency financial assistance;
- Improve the management, including financial management, related to the operation of community facilities; or

Assist with other areas of need identified by the Secretary.

Eligibility and Description/Use: Healthcare Institution, Nonprofit Organizations, Public/Private Institutions of Higher Education Annual TAT - Eligible entities must be private nonprofit organizations. Applicants must have proven ability, background, experience, legal authority and actual capacity to provide technical assistance and/or training on a regional basis to associations. TAT/RWTS - Eligible entities must be consortiums (regional institutions of higher education, academic health and research institutes or economic development entities, or combination thereof, located in the region identified to be served that have experience in addressing these issues in the region). Applicants must have proven ability, background, experience, legal authority and actual capacity to provide technical assistance.

R3. FY21 Distance Learning & Telemedicine (DLT) Grants (10.855)

Resource Type: Grant

Agency/Organization: Department of Agriculture

Funding Type: Non-Supplemental

Program Description: The DLT Program provides financial assistance to enable and improve distance learning and telemedicine services in rural areas. DLT grant funds support the use of telecommunications-enabled information, audio and video equipment, and related advanced technologies by students, teachers, medical professionals, and rural residents. These grants are intended to increase rural access to education, training, and health care resources that are otherwise unavailable or limited in scope.

Applicants are encouraged to consider projects that provide measurable results in helping rural communities build robust and sustainable economies through strategic investments in infrastructure, partnerships and innovation.

Key strategies include:

- Achieving e-Connectivity for Rural America
- Developing the Rural Economy
- Harnessing Technological Innovation
- Supporting a Rural Workforce
- Improving Quality of Life

Grant funds may be used for:

- Acquisition of eligible capital assets, such as:
 - Broadband facilities
 - o Audio, video and interactive video equipment

- o Terminal and data terminal equipment
- O Computer hardware, network components and software
- o Inside wiring and similar infrastructure that further DLT services
- Acquisition of instructional programming that is a capital asset
- Acquisition of technical assistance and instruction for using eligible equipment

R4. American Rescue Plan Act: FY21 Pediatric Mental Health Care Access Program - New Area Expansion (93.110)

Resource Type: Cooperative Agreement

Agency/Organization: Department of Health and Human Services

Funding Type: Supplemental

Program Description: The Health Resources and Services Administration (HRSA) is accepting applications for the fiscal year (FY) 2021 American Rescue Plan Act: Pediatric Mental Health Care Access – New Area Expansion. The purpose of this program is to promote behavioral health integration into pediatric primary care by supporting pediatric mental health care telehealth access programs.

This funding opportunity will expand the Pediatric Mental Health Care Access Program into new states and geographic areas. Newly expanded state or regional networks of pediatric mental health care teams will provide tele-consultation, training, technical assistance, and care coordination for pediatric primary care providers to diagnose, treat, and refer children with behavioral health conditions. For the purposes of this funding opportunity, telehealth is defined as the use of electronic information and telecommunication technologies to support and promote clinical consultation, patient and professional health-related education, public health, and health administration activities.

HRSA estimates approximately \$71,200,000 to be available to fund up to 32 new recipients over 5 years. You may apply for a ceiling amount of up to \$445,000 total cost (includes both direct and indirect, facilities and administrative costs) per year. The period of performance is September 30, 2021 through September 29, 2026 (5 years). Funding beyond the first year is subject to satisfactory recipient performance, and a decision that continued funding is in the best interest of the Federal Government

R5. American Rescue Plan: FY21 Health Center Construction & Capital Improvements (93.526)

Resource Type: Grant

Agency/Organization: Department of Health and Human Services

Funding Type: Supplemental

Program Description: The Health Resources and Services Administration (HRSA) is accepting applications for the fiscal year (FY) 2021 American Rescue Plan – Health Center Construction and Capital Improvements (ARP-Capital) funding opportunity. The purpose of this one-time funding opportunity is to support construction, expansion, alteration, renovation, and other capital improvements to modify, enhance, and expand health care infrastructure.

HRSA will provide approximately \$1 billion for an estimated 1,376 awards to all eligible health centers that submit a completed application.

HRSA will provide funding in the form of a grant. The amount of funding awarded to each recipient will be determined according to the following formula:

- \$500,000 base amount, plus
- \$11 per patient as reported in 2019 UDS.

You may submit **one** application to request funding to support one or more of the following project types, for up to five (5) total projects:

- Construction of a New Facility: This project creates a new building structure. Activities in this project include construction of a new stand-alone structure.
- Construction/Expansion (C/E) of an Existing Facility: This project adds square footage to an existing facility and/or includes significant site work.
- Alteration/Renovation (A/R) of an Existing Facility: This project involves renovations to an existing facility that does not increase square footage of the facility.
- **Equipment Only:** This project involves the acquisition of loose, moveable equipment not affixed to the physical building structure.

Max Award: \$500,000 base amount, plus \$11 per patient as reported in 2019 UDS.

Eligibility and Description/Use: Healthcare Institution Only Health Center Program award recipients (organization funded under Section 330(e), (g), (h), and/or (i) of the Public Health Service Act, as amended) with active H80 grant awards may apply for ARP-Capital funding.

R6. American Rescue Plan: FY21 Rural Testing Relief Fund - Rural Health Clinic COVID-19 Testing & Mitigation Program

Resource Type: Grant

Agency/Organization: Department of Health and Human Services

Funding Type: Supplemental

Program Description: HRSA's Rural Health Clinic COVID-19 Testing and Mitigation Program will provide \$460 million to more than 4,600 rural health clinics (RHCs) across the country. RHCs will use the funds to maintain and increase COVID-19 testing, expand access to testing for rural residents, and broaden efforts to mitigate the spread of the virus in ways tailored to their local communities. RHCs are a special certification given to health care practices in underserved rural areas by the Centers for Medicare and Medicaid Services (CMS) to help ensure access to care for rural residents. HRSA will provide up to \$100,000 per RHC-certified clinic site and will issue the funds this summer.

R7. American Rescue Plan: FY21 Small Rural Hospital Improvement Program (SHIP) (93.301)

Resource Type: Grant

Agency/Organization: Department of Health and Human Services

Funding Type: Supplemental

Program Description: To further support COVID-19 testing in rural areas, HRSA will provide \$398 million to existing grantees of the Small Rural Hospital Improvement Program (SHIP) to work with approximately 1,730 small rural hospitals – those with fewer than 50 beds – and Critical Access Hospitals on COVID-19 testing and mitigation. SHIP state grantees will use the funding to support all eligible rural hospitals, up to \$230,000 per hospital, and will issue the funds later in the year.

R8. CARES Act: FY20 Runaway & Homeless Youth - Transitional Living Program (93.550)

Resource Type: Grant

Agency/Organization: Department of Health and Human Services

Funding Type: Supplemental

Program Description: The Purpose of FYSB's Transitional Living Program (TLP) for Older Homeless Youth grant program is to implement, enhance, and/or support effective strategies for successful transition to sustainable living for runaway and homeless youth ages 16 to under 22 and/or pregnant and parenting youth ages 16 to under 22 and their dependent child(ren).

Projects must provide safe, stable, and appropriate shelter for up to 18 months, which under extenuating circumstances, can be extended to 21 months and provide comprehensive services that supports the transition of homeless youth to self-sufficiency and stable, independent living. Through the provision of shelter and an array of comprehensive services, TLPs offer or refer for the following services:

- Safe, stable living accommodations;
- Basic life skills building including consumer education, budgeting, housekeeping, food preparation and parenting skills;
- Educational opportunities such as GED preparation, post-secondary training, and vocational education;
- Job attainment services such as career counseling and job placement;
- Mental health care including individual and group counseling; and
- Physical health care such as physicals, health assessments, and emergency treatment.

R9. COVID-19 Supplementals: FY20 Emerging Infections Program (93.317)

Resource Type: Cooperative Agreement

Agency/Organization: Department of Health and Human Services

Funding Type: Supplemental

Program Description: Funding from PL 116-123 will be used to supplement an existing cooperative agreement to state jurisdictions through the Emerging Infections Program (EIP) to enhance surveillance capabilities. Activities include investigating and assessing the burden and severity of COVID-19, evaluating and determining risk factors and outcomes, and planning and implementing prevention strategies. These activities will build on existing programs developed for influenza and other respiratory pathogens. Funds will also be used to assess and evaluate exposed/infected healthcare personnel through clinical interviews to better identify risk factors and protective factors for COVID-19 infection.

The purpose of the Emerging Infections Programs (EIP) is to assist in local, state, and national efforts to prevent, control, and monitor the public health impact of infectious diseases. The EIP cooperative agreement was formed in 1995 as a key component of CDC's national strategy to address and reduce emerging infectious disease (EID) threats.

The EIP is a population-based network of state health agencies and their collaborators, including (but not limited to) academic institutions, local health departments, public health and clinical laboratories, infection control professionals, and healthcare providers. The network plays a critical role in conducting surveillance and applied epidemiologic and laboratory research, implementing and evaluating prevention and intervention projects, and responding quickly to new infectious disease issues. The unique strength of the EIP lies in the network's ability to quickly translate surveillance and research activities into informed policy and public health practice.

The EIP infrastructure depends on a direct relationship with public health agencies that have sufficient legal authority and responsibility to perform public health surveillance and response activities. The network must also consist of definitive populations large enough to adequately determine disease burden, evaluate large scale interventions, and impact public health policy decisions.

Activities for this program fall into the following general categories: (1) active surveillance; (2) applied public health epidemiologic and laboratory activities; (3) implementation and evaluation of pilot prevention/intervention projects; and (4) flexible response to public health emergencies. Activities: (1) address issues that the EIP network is particularly suited to investigate; (2) maintain sufficient flexibility for emergency response and new problems as they arise; (3) develop and evaluate public health interventions to inform public health policy and treatment guidelines; (4) incorporate training as a key function; and (5) prioritize projects that lead directly to the prevention of disease (http://wwwlink.cdc.gov/ncezid/dpei/eip). Activities include conducting active, population-based surveillance and special studies for invasive bacterial diseases, foodborne pathogens, healthcare associated infections (HAIs), influenza, and many other infectious diseases.
