**Compact Operational:** A compact is operational when it is actively accepting applications from eligible professionals for the compact's services.

**Jurisdictions:** States, Territories, and Districts of the United States of America

**Not Eligible:** Per the Dietitian Licensure Compact, these states are not eligible to join the compact because they do not currently license or certify dietitians.

**MR:** Mutual Recognition. This licensing model generally provides privileges to practice in all compact member jurisdictions via a single compact application.

**EL:** Expedited Licensure. This licensing model facilitates an expedited pathway to obtaining licenses in one or more of the compact member jurisdictions.
